To File an Appeal to the State Board:

- Provide a request in writing made regarding the appeal to The Board of Electricians' Appeals, 1000 Washington Street, Suite 710, Boston, MA 02118-6100.
- ➤ Provide the notice of disapproval received by wiring inspector
- Bring a check or money order for \$86 made payable to the Commonwealth of Massachusetts.

Why the 1:1 Ratio in Massachusetts is law:

How is an electrical apprentice able to work without an electrical license in MA? This is where state laws and regulations come into play! The 1:1 Ratio law allows an apprentice to get credit for the hours worked toward his/her license without having an electrical license in Massachusetts.

Top 5 state complaints against electricians and unlicensed electricians in MA

- 1. Electricians or unlicensed workers not having proper name and license number on truck, business cards, business documents, and social media
- 2. Contractual matters between electrician and customer
- 3. Unprofessional work on the job
- 4. Unlicensed electrical work
- 5. Price gouging of electricians

This can change!

Each year thousands of complaints about licensed electricians and unlicensed workers who are not following their own state rules can result in state hearings, criminal hearings, state attorneys, court fees, and penalties.

This is What Happens When You File a Complaint against an Electrician

Call the State Consumer Protection Hotline at 617-727-7406 You will be asked to file a complaint form

The electrician or unlicensed worker will receive a letter from the state investigation office asking for his/her side of the story. Then when all facts are in from both sides of the parties involved the State will make a decision to take further action on the complaint or close the complaint. The facts from both sides/parties involved are very important so that the state makes a fair decision on the complaint against a licensed electrician or unlicensed worker.

Here is a partial list of State Complaints against an electrician or unlicensed worker:

- Electrician was price Gouging
- Unlicensed electrical work performed
- Electrical work not completed on the job
- An expired licensee working on the job
- Electrician not following their State laws and Regulations from the State Board office
- Consumer not Happy with electrician
- Unsafe electrical work found by an electrician
- Electrical hazard reported by the inspector of wires
- Electrical Fire on the job under investigation
- Section eight electrical meter cost problem
- Electrician Working without proper name/license on truck, business cards, and social media
- Electrician violated the MA Building Code requirement
- No written contract between both parties involved, Only verbal electrician vs consumer
- Customer never payed me for the work performed court? electrician never finished the work
- Electrician and apprentice didn't have Workers liabilities/Completion Insurance for work performed or workers compensation insurance for employee
- Electrician did NOT act professional on the job
- Electrician removes electrical service from the building because of non-payment
- Electrical Corporation doing work with the wrong master licensed board officer in place
- Electrical Ratio 1:1 problem, MGL 141 s. 8
- Fire Permit and inspection not obtained or performed from the local fire department

- Inspector of wires and electrician code dispute
- Electrician did not meet minimum electrical Code requirement
- Consumer wants an answer about her costly bill
- The Electrical permit was not obtained within the 5 days from start of the electrical work
- Electrical Work performed NO license and permit obtained from city or town
- Electrician asks who has jurisdiction over me the utility or inspector of wires
- Two journeyman electricians caught working in the business together
- State Reciprocate electrical license had expired
- Shipyard worker wants an electrical license
- C-license worked on security without S-license in place from the department of public safety
- Electrician never completed the 15-hour Mandatory license renewal class may have to take test again
- Electrician or unlicensed worker was NOT working under the name stated on his/her license
- Apprentice needed Form 272 filled out by employer No Payroll records
- Utility wants electrician to remove SE cable from meter socket to weather head on an overhead service

Sample letter of complaint:

Our State Office of Investigation has just received a complaint against your electrical license. We ask that you supply our office with your side of the story. We will need the following information from you so we can resolve this state complaint against you. Not supplying our office with the appropriate information could result in us bringing this matter to the attention of the State Board of Examiners of Electricians to take disciplinary actions against you as a licensed electrician. Please send us the following information as needed below to help close this State Complaint:

If a State complaint is filed against you, now you must present the State with one or more factual documents listed below and the State electrical permit is always asked for - we have a partial list below:

- Electrical job photos regarding your complaint
- Signed job contract of work performed between both parties
- Written estimate of job signed by both parties
- Written Inspector of Wires notice of 527 CMR 12.00 violation
- Witten electrical hazard reported by inspector of wires
- County Civil Court decision to finish work the electrician refused to finish because of non-payment
- Electric Utilities notice of violation in your jurisdiction
- OHSA violation(s) and/or OHSA Card
- Copy of your updated MA Electrical License (A), (B), (C), (D) if unlicensed work is performed it should be filed in the county criminal court by the local inspector of wires
- Machine Operator's License if Need Ratio problem
- Job stop notice by the building department in writing
- Your business advertisement business cards, truck logo, photo, website, Facebook page, estimates, contracts with license number and name – must be same as written on your electrical license
- Electrical job site ratio problem 1:1 in MA video recorded of factual information, photos, or written state electrical investigator report or written inspector of wires report
- Building code violation notice by a building inspector or any other official in that town or city, such as a zoning inspector
- Price gouging of electrical work in MA will need a written contract between both parties
- Electrical MCE review, 15- and 6-hour problem with license renewal send your certificate of proof into state office
- Electrical permit (must submit) be dated within 5 days of the start of work from a town or city where the work took place must be filed with this state complaint
- The Board of Examiners of Electrician's appeal notice electrician can appeal an inspector's decision
- Written Inspector of Wires report submitted about hazardous electrical work performed by electrician
- Electrical union notice of type of work in detail on job site

- Expired electrical license state Electrical Board will take notice this could be considered as working without a license! a criminal matter!
- Fire permit or fire violation notice
- Copy of (C) fire or security contractor license or (D) fire or security technicians license
- Electrical fire report from the State Fire Marshall's Office
- The electrical master name and license number of the officer of the corporation doing work in MA
- Copy of S-license
- Copy of liability completion insurance information
- Copy of your workers compensation information
- Company names of those who were subcontracted on the job electrical can't subcontract electrical work in Massachusetts

We know the Board of State Examiners of Electrician's wants all licensed electricians/fire and security to follow all Board Regulations and MA State laws on the job sites at all times.

After the Board of Examiners of Electricians hears your complaint and acts on your state complaint/case, your complaint can be taken to the county criminal court where the violation took place.

An electrical code violation will get you a disapproval notice from the Inspector of Wires, but a violation of a State law will get you State and Criminal court hearings.

Education is your best bet! We are Electricians helps professional electricians avoid getting caught up in state and county hearing/court systems.
